Every person engaged or intending to engage in any calling, business, occupation or profession, in whole or part, within the limits of the City of Travelers Rest, South Carolina is required to pay an annual license fee and obtain a business license as herein provided. The required license fee shall be paid for each business subject hereto according to the applicable rate classification on or before the 30th day of April in each year in order to avoid a late penalty of 5% of the unpaid fee for each month or portion thereof after the due date until paid, except for those businesses in Rate Class 8.1 for which a different due date is specified. *The gross income for business license purposes may be verified by inspection of returns and reports filed with the Internal Revenue Service, the South Carolina Department of Revenue, the South Carolina Insurance Commission, or other government agency.

The issuance of a business license is conditioned upon strict compliance with the ordinances of the City of Travelers Rest and failure to comply may result in revocation of license and possible monetary fines. This is to certify that the above information is a true statement of the business done or transacted at or through the above location.
