Public Works Summary for January 2023

- Sanitation: We are still getting request for recycle carts and Greater Greenville has been delivering these as they come in. Our recycling program continues to increase, and we expect this to continue as the roll carts are rolled out. The RFP went out for sanitation services. We have had three companies reach out with interest.
- <u>Road and Bridge</u>: We had a total of 10 complaints from road and bridge to include roadside litter pick up. 6 of these complaints were handled by the city. The other 4 were sent over to SCDOT or Greenville Water System. The lane restriping on Roe Rd has been completed. We also added about 13 parking spaces along Main Street.
- <u>Sewer</u>: We pumped three septic tanks in the month of January. We are working with Metro on getting to sewer transferred. We had one sewer service call. And one sewer evaluation was completed.
- **Building / Grounds Maintenance:** Several maintenance issues were addressed at Trailblazer Park. All the Christmas Décor was taken down.
- <u>Miscellaneous Items</u>: We are waiting on the county rec to get quotes back planning to apply a seal coat to the section of the trail in front of Loftis Printing to Roe Rd. Greenville County will provide the contractor for this. Work has started at Athens Park on the basketball courts. We have installed all the seasonal decorations along. A bike repair station has been installed on the Trail across from city hall. We are planning to install the eco counter on the trail the week of February 13th.
- **<u>SC 811:</u>** We are working with Metro to get the located turned over to them.



Sec. 1. Title

ORDINANCE PROHIBITING SMOKING IN ALL WORKPLACES AND CERTAIN OUTDOOR SPACES

This Ordinance shall be known as the Travelers Rest Smoke Free Air Ordinance of 2023.

Sec. 2. Findings and Intent

The City Council of Travelers Rest does hereby find that:

- A. The 2006 U.S. Surgeon General's Report, The Health Consequences of Involuntary Exposure to Tobacco Smoke, has concluded that secondhand smoke exposure causes disease and premature death in children and adults who do not smoke.
- B. Accordingly, the City Council of Travelers Rest finds and declares that the purposes of this ordinance are:

(1) to protect the public health and welfare by prohibiting smoking in workplaces and certain outdoor spaces; and

(2) to guarantee the right of nonsmokers to breathe smoke free air, and to recognize that the need to breathe smoke free air shall have priority over the desire to smoke.

Sec. 3. Definitions

The following words and phrases, whenever used in this Ordinance, shall be construed as defined in this Section:

- A. "Alternative Nicotine" means any electronic oral device, such as one composed of a heating element, battery, and/or electronic circuit, which provides a vapor of nicotine or any other substances, and the use or inhalation of which simulates smoking. The term shall include any such device, whether manufactured, distributed, marketed, or sold as an e-cigarette, e-cigar, ecigarillo, e- pipe, or under any other product name or descriptor.
- B. "Enclosed" means all space between a floor and a ceiling that is bounded on all sides by walls, doorways, or windows, whether open or closed. A wall includes any retractable divider, garage door, or other physical barrier, whether temporary or permanent.
- C. "Smoking" means inhaling, exhaling, burning, or carrying any lighted cigar, cigarette, or pipe, or any other lighted tobacco or plant product intended for inhalation, in any manner or in any form. "Smoking" also includes the use of alternate nicotine products which create a vapor, in any manner or in any form, or the use of any oral smoking device for the purpose of circumventing the prohibition of smoking in this Ordinance.
- D. "Workplace" means an enclosed area under the control of an employer, including, but not limited to, retail stores, restaurants, work areas, private offices, employee lounges, restrooms, conference rooms, meeting rooms, classrooms, employee cafeterias, hallways, and vehicles. A private residence is not a "workplace" unless it is used as a child care, adult day care, or health care facility.

Sec. 4. Prohibition of Smoking in Enclosed Workspaces

Smoking shall be prohibited in all workplaces within the city limits of Travelers Rest.

Sec. 5. Prohibition of Smoking in Certain Outdoor Spaces

Smoking shall be prohibited in the following outdoor spaces:

- A. Within 20 feet of entrances or operable windows;
- B. In or within 20 feet of outdoor seating or serving areas of restaurants;
- C. Within 20 feet of ventilation systems of enclosed areas where smoking is explicitly prohibited;
- D. In or within 20 feet of any sidewalks, trailways, parks, ballparks, playgrounds, amphitheaters, and city-maintained parking areas.

Sec. 6. Where Smoking Not Regulated

Notwithstanding any other provision of this Ordinance to the contrary, the following areas shall be exempt from the provisions of Section 4:

- A. Private residences, unless used as a licensed childcare, adult day care, or health care facility.
- B. Bars, Brewpubs, and Drinking Places, provided that smoke from the establishment does not infiltrate into areas where smoking is prohibited under the provisions of this article.
- C. Retail tobacco stores, provided that smoke from these places does not infiltrate into areas where smoking is prohibited under the provisions of this article. No business license or certificate of occupancy may be issued for a retail tobacco store without the applicant first providing a detailed plan for compliance with this provision.
- D. Hotel and motel rooms that are rented to guests and are designated as smoking rooms; provided, however, that not more than 20 percent of rooms rented to guests in a hotel or +motel may be so designated. All smoking rooms on the same floor must be contiguous and smoke from these rooms must not infiltrate into areas where smoking is prohibited under the provisions of this article. The status of rooms as smoking or nonsmoking may not be changed, except to add additional nonsmoking rooms.

Sec. 7. Posting of Signs

- A. The prohibition on smoking in any workplace shall be communicated by all employers to all existing employees by the effective date of this ordinance, and to all prospective employees upon their application for employment;
- B. The person or entity having control of the workplace shall be responsible for placing "NO SMOKING" signs in conspicuous areas at the workplace.


Sec. 8. Violations and Penalties

- A. The person or entity who owns, manages, operates or otherwise controls a place of employment and who fails to comply with the provisions of this article shall be guilty of an infraction, punishable by a fine not to exceed \$25 per infraction.
- B. A person who smokes in an area where smoking is prohibited by the provisions of this article shall be guilty of an infraction, punishable by a fine not to exceed \$25 per infraction.
- C. Each violation of this Ordinance shall be considered a separate and distinct violation.

Sec. 9. Effective Date

This Ordinance shall be effective thirty (30) days from and after the date of its adoption.

- Sheltering of lost and homeless pets (on average 14 days of care per animal)
- Lost and Found pet reunification program
- Medical care for shelter pets provided by a team of licensed veterinarians and vet assistants
- Placement programs, including pet adoption, foster care, and rescue group transfer programs
- Supported self-rehoming program for pet owners who need to rehome a pet.

ANIMAL SERVICES AGREEMENT

This Services Agreement ("Agreement") is entered into on this <u>1st DAY OF JULY 2023</u>, by and between the County of Greenville (hereinafter "County"), a duly organized and validly existing body politic of the State of South Carolina, having its principal place of business at 301 University Ridge, Greenville, S.C. 29601, and the City of Travelers Rest, (hereinafter "City"), a duly organized and validly existing body politic of the State of South Carolina, having its principal place of business at 125 Trailblazer Drive, Travelers Rest, S.C. 29690.

In consideration of the covenants hereinafter set forth, the parties mutually agree as follows:

1. CONTRACT PERIOD

The term of this Agreement shall commence on <u>JULY 1, 2023</u> and terminate on <u>JUNE 30, 2024</u>, unless earlier terminated by the parties as elsewhere set out in this Agreement. The parties may extend this Agreement for <u>ONE YEAR</u> by mutual agreement between the parties at least <u>THIRTY</u> (30) DAYS before the end of the then current term.

2. SCOPE OF SERVICES

City hereby contracts with County for County to provide shelter, wholesome food, water, and basic veterinary care for dogs and cats impounded and delivered to Greenville County Animal Care by City agents, to include City Animal Control Officers or City Law Enforcement Officers. It is understood by the parties that County will not take owner surrenders brought in by City citizens without an appointment and citizens may be subject to applicable fees to use County's animal services.

DOGS: It is understood and agreed that County shall receive healthy stray dogs delivered by City agents between the hours of 8:00 AM to 4:00 PM Monday through Friday. County shall receive injured and sick stray dogs between the hours of 8:00 AM to 4:30 PM Monday through Friday. County will not accept injured and/or sick dogs after hours or on weekends. City agents shall give prior notice via telephone call when delivering a sick or injured dog to County. An indoor/outdoor kennel is available and accessible at the designated location at 328 Furman Hall Road in Greenville should City agents need temporary after-hours and weekend housing for healthy stray dogs.

CATS: It is understood that healthy free roaming cats shall not be delivered to Greenville County Animal Care as strays for housing. A community cat trap-neuter-return program has been implemented in Greenville County and all healthy free roaming cats are expected to be spayed or neutered, vaccinated, ear-tipped as a means of identifying an altered community cat, and returned to the cat's outdoor home area. City agents are expected to educate its citizens on the countywide community cat trap-neuter-return program and direct them to County's free and low-cost spay/neuter services. Cats that are ineligible for County's community cat trap-neuter-return program due to age, health, or other disabling factors may be delivered to Greenville County Animal Care between the hours of 8:00 AM to 4:00 PM Monday through Friday. County shall receive injured and sick stray cats between the hours of 8:00 AM to 4:30 PM Monday through Friday. County will not accept injured and/or sick cats after hours or on weekends. City agents shall give prior notice via telephone call when delivering a sick or injured cat to County. An indoor/outdoor kennel is available and accessible at the designated location at 328 Furman Hall Road in Greenville should City agents need temporary after-hours and weekend housing for healthy stray cats.

IDENTIFICATION OF LOST PETS: Prior to delivering stray and/or lost dogs and/or cats to Greenville County Animal Care, City agents are expected to scan every lost and/or stray dog and/or cat for pet identification, including a tattoo, any implanted microchip, or similar device that provides evidence of ownership pursuant to § 47-3-55, South Carolina Code of Laws, providing scanning the animal for identification does not jeopardize human safety. City agents shall make a good faith

effort to locate the owner of identifiable dogs and cats and return them to their owner(s) in the field before delivering said animal(s) to Greenville County Animal Care. Upon delivery of said animal(s), County and its employees shall scan every lost and/or stray dog and/or cat for pet identification, including a tattoo, any implanted microchip, or similar device that provides evidence of ownership pursuant to § 47-3-55, SC Code of Laws, providing scanning the animal for identification does not jeopardize human safety. County and its employees shall make a good faith effort not to destroy any positively identifiable animal until they and/or City make good faith effort to notify an owner of the animal(s) at his/her last known address.

HOLDING PERIOD AND EXCEPTIONS: Stray and/or lost dogs and pet cats delivered by City will be housed at Greenville County Animal Care for a minimum of five (5) days to allow time for owners to identify and claim lost pets with the following exceptions:

- Those animals that are seriously ill or are injured to the point that the animal is suffering or in a condition that is medically unrecoverable to normal health, as determined by a veterinarian, will be humanely euthanized by County.
- 2. Feral animals, defined as an animal that is existing or has returned to a wild or untamed state, are not domesticated pets and may be humanely euthanized by County prior to the completion of a five (5) day holding period, as determined by a veterinarian. Feral cats eligible for County's community cat program may be spayed/neutered and returned to their outdoor home living area immediately after intake.
- Litters of unidentifiable dogs or cats four months of age or younger will be exempt from the five
 (5) day holding period and may be turned over to any organization established for the purpose of caring for animals immediately, so long as the litter is turned over for life-saving purposes, pursuant to § 47-3-60, South Carolina Code of Laws.

- Stray and/or lost dogs and cats already housed by City for a minimum of five (5) days prior to delivering said animal to County will be exempt from additional holding periods.
- 5. All stray and/or lost animals delivered to County may, at County's discretion, be transferred to an approved foster care home for the duration of the animal's holding period. During this time, the animal remains under the care and protection of County and the animal shall be returned to County's animal care facility within twenty-four (24) hours at the request of a County employee or City agent.

DISPOSITION: All other City stray and/or lost dogs delivered to County, after the five (5) day holding period, shall become the property of County and may be adopted, turned over to any organization established for the purpose of caring for animals, or euthanized as County chooses, with the following exception: those animals that are seized and delivered to County by a City agent and identified by such agent as animals to be held for pending judicial process, or other causes as requested by City, shall be held by County and not destroyed, given for adoption, or otherwise disposed for a period up to but not to exceed thirty (30) days from intake date. If said animal(s) require a long term holding period for pending judicial process more than thirty (30) days, City will be expected to make long term housing arrangements at another facility and transport animal(s) to that location. County may retain all fees associated with adoption, reclaim, or any other placement revenue.

3. PRICE AND PAYMENT

City agrees to pay County, and County agrees to accept as full compensation, the sum of <u>ONE</u> <u>HUNDRED DOLLARS (\$100.00)</u> per animal delivered and impounded to County during the term of this Agreement. Animals held as evidence for pending judicial process, rabies bite quarantine, or by request of a City agent for other causes beyond the initial five (5) day holding period will be subject to a <u>TWENTY-FIVE DOLLARS (\$25.00)</u> per day additional charge until the court disposition, quarantine release, or other release from impoundment. County shall invoice City at the end of each month based on the price and payment structure set forth above, and shall include with each invoice a summary report of animals received by City during the billing cycle. City may also provide a summary report of every animal delivered to County during the billing cycle for auditing purposes. Payments shall be made within fifteen (15) days of receipt of invoice. Payments shall be made payable to Greenville County Animal Care and mailed as follows:

4. STANDARD OF CARE

Services performed by County will be conducted in accordance with federal law, South Carolina law, and applicable regulations and local ordinances for both County and City, and in a manner that is consistent with that level of care and skill exercised by members of the same profession providing the same or similar services with comparable experience and qualifications to those of County. City reserves the right to inspect County's animal care facility at random times but with prior notice to County. County shall be responsible for the maintenance and repairs to the animal care facility. If at any time City has a reasonable basis on which to believe that County's animal care facility is not being maintained in an appropriate manner, it shall have the right to consider terminating this Agreement.

5. TERMINATION OF AGREEMENT

City may terminate this Agreement for any reason, as City in its sole discretion shall decide, upon thirty (30) days written notice to County. County may terminate this Agreement for any reason, as County in its sole discretion shall decide, upon thirty (30) days written notice to City. Should City fail to make payment to County of any undisputed amounts due, County, at its discretion, may terminate this Agreement upon written notice to City, or suspend services to City until all amounts due and in arrears are paid by City. Termination of this Agreement shall not relieve either party of any obligation incurred one to the other before the termination. Specifically, City agrees to pay County for all services provided to City before termination. Should either party terminate this Agreement before JUNE 30, 2024 according to the terms as set forth in this Agreement, then the parties will determine any amounts that may be owed. Any payment owed shall be calculated by multiplying the actual number of dogs and cats received by County from the previous billing cycle through the date of termination by **ONE HUNDRED DOLLARS (\$100.00)**, plus an additional TWENTY-FIVE DOLLARS (\$25.00) per day charge for each animal held as evidence for pending judicial process, rabies bite quarantine, or by request of a City agent for other causes beyond the initial five (5) day holding period from the previous billing cycle. County shall invoice City at the end of each month based on the price and payment structure set forth above, and shall include with each invoice a summary report of animals received by City during the billing cycle.

6. INSURANCE

County shall maintain its standard Insurance Policy for the duration of this Agreement against all claims for injuries to persons or damages to property that may in any way arise from, or in connection with, the performance of the services hereunder by County, its subcontractors, agents, representatives or employees.

7. TRAINING

County agrees to provide necessary training to City agents as required, to include drop off routines, facility policies and intake procedures, safe and humane animal handling techniques, animal tranquilization guidelines, quality of life and standards of care, and any other training determined necessary to ensure effective daily animal shelter operations and humane care and treatment of all animals delivered to County's animal care facility by City agents. City agrees to follow all applicable policies and procedures outlined in the training County provides to ensure effective daily animal shelter operations delivered to County's animal care facility by City agents.

8. NOTICES

All notices required shall be in writing and shall be deemed to have been duly given if either handdelivered or mailed by certified or registered mall, return receipt requested, postage prepaid, addressed to the party to whom intended to the address below or at another address as the party shall designate to the other party in writing:

Any notice so mailed shall be deemed to have been given and received by the party to whom addressed on the third (3rd) day after the date notice was properly deposited in the mail.

9. ENTIRE AGREEMENT

This Agreement constitutes the entire agreement between the parties and may not be modified or amended except in writing signed by both parties. In the case of any conflict between the terms and conditions of this Agreement and the terms of any other agreement between the parties, the terms of this Agreement shall control.

10. ASSIGNMENT

This Agreement may not be assigned by either party, in whole or in part, without the prior written consent of the other party.

11. SEVERABILITY

If any part or provision of this Agreement Is held invalid or unenforceable under applicable law, such invalidity or unenforceability shall not in any way affect the validity or enforceability of the remaining parts and provisions of this Agreement.

12. NON WAIVER

The waiver by City or County of a breach of this Agreement shall not operate as a waiver of any subsequent breach, and no delay in acting with regard to any breach of this Agreement shall be construed to be a waiver of the breach.

13. APPLICABLE LAW AND VENUE

This Agreement and the rights, obligations and remedies of the parties hereto, shall in all respects be governed by and construed in accordance with the laws of the State of South Carolina. The parties further agree that this Agreement shall be deemed to be made and performed in Greenville, South Carolina. For the purposes of venue, all suits or causes of action arising out of this Agreement shall be brought in the courts of Greenville County, South Carolina.

14. SUCCESSORS AND ASSIGNS

The rights and obligations of this Agreement shall inure to and be binding upon the successors and assigns of the parties.

The City recently conducted a review and peer comparison of observed city holidays. Based on this review I recommend that the City Council consider adding Juneteenth (June 19th) and Veteran's Day as designated paid holidays.

Juneteenth is a federal holiday in the United States commemorating the emancipation of enslaved African Americans. Juneteenth has since been observed annually in various parts of the United States, often broadly celebrating African-American culture. The day was first recognized as a federal holiday in 2021.

Veterans Day (Prior to 1954 known as **Armistice Day**) is a federal holiday observed annually on November 11, for honoring military veterans of the United States Armed Forces.

The City of Travelers Rest currently observes these 10 holidays:

- Memorial Day
- Independence Day
- Labor Day
- Thanksgiving Day
