#### 1. Call to Order and Pledge of Allegiance

- a. Mayor Pro Tem Bumgarner called the meeting to order at 6:00 p.m.
- b. Council and staff recited the Pledge of Allegiance

#### 2. Invocation

a. The Invocation was given by Councilmember Vest

#### 3. Approval of the Minutes of Previous Meeting

a. Mayor Amidon called for a motion to approve the minutes for the Regular Council Meeting held on February 15, 2024. Councilmember Criss motioned to approve. The motion was seconded by Councilmember Marrah and carried unanimously.

#### 4. Presentation by Greenville County Redevelopment Authority

- a. Imma Nwobodu, from GCRA, gave a presentation about the Annual Action Plan for the City of Travelers Rest for 2024. She discussed the funds we would receive from the US Department of Housing and Urban Development. The focus of the presentation was on HOME and CDBG funds.
- b. Mayor Pro Tem Bumgarner confirmed that the funds would not expire and that they can be rolled over year over year. Councilmember Marrah wanted

confirmation that the city would receive a reminder prior to the money expiring.

#### 5. Public Hearing

a. Mayor Pro Tem opened up the public hearing. After no response, he closed the public hearing.

#### 6. Ordinances & Resolutions for Second Reading

- a. Bowers Road Annexation (O-03-24) Councilmember Vest made a motion to approve the annexation. Councilmember Criss seconded the motion. It was opened up for comment to the Council. Councilmember Lane wanted confirmation that if it wasn't approved, it would still tie into Metroconnect. Councilmember Vest stated that he believed it would on the county level. The motion carried with 6 for and 1 against (Councilmember Lane).
- b. Bowers Road Zoning Map Amendment (O-03-24) Councilmember Vest made a motion to approve the zoning map amendment. Councilmember James seconded the motion. Mayor Pro Tem Bumgarner opened it up for discussion. Councilmember McCall wanted to emphasize that the the amendment is much more stringent and it gives the Council more control and leverage. The motion passed unanimously.
